For Action

Please review your platelet ordering practice

We are respectfully requesting that you review your practice in line with our guidance, to help us ensure equitable availability for all hospitals.

Our guidance is that you:

- Order in line with BSH guidelines to help us maintain the availability of higher specification platelets for those patients who need them.
- Consider the clinical requirement before specifying apheresis and / or CMV negative requirements. Please refer to the <u>Apheresis Platelet Myth Buster</u> on the Hospitals and Science website for further information.
- Do not request High Titre negative for ABO identical platelet transfusion.
- Accept substitution of D negative units for D positive requests, or irradiated units for non-irradiated requests. You will not incur any additional charge for substituted units.

Whenever possible we will supply units requested for stock with a minimum 48 hours shelf life from receipt, in accordance with your blood and blood component contract.

If you think this may raise concerns in your laboratory, please discuss with your Hospital Services team or Customer Services Manager.

Please follow our process for reporting leaking red cell and platelet packs

The process has been standardised to improve accuracy, ensure comprehensive data is obtained and will help to inform future actions that may be taken to reduce the frequency, and subsequent wastage, of leaking packs reported by hospitals.

When a leaking red cell or platelet pack is identified, and the cause may be due to a potential pack defect, you should:

- report it to Hospital Services, then
- quarantine the unit, then
- return the unit in a bio-hazard bottle for investigation

Please cascade the process to relevant staff.

Hospitals should only <u>request a credit</u> for leaking or associated contaminated packs if they have been reported.




