

Northern Ireland Organ Donation Services Team

Taking Organ Transplantation to 2020

In 2018/19, from 57 consented donors the Northern Ireland Organ Donation Services Team facilitated 44 actual solid organ donors resulting in 107 patients receiving a life-saving or life-changing transplant. Data obtained from the UK Transplant Registry.

In addition to the 44 proceeding donors there were 13 consented donors that did not proceed.


Best quality of care in organ donation

Referral of potential deceased organ donors

Goal: Every patient who meets the referral criteria should be identified and referred to NHS Blood and Transplant's Organ Donation Service

Aim: There should be no purple on the chart

Aim: The team (marked with a cross) should fall within Bronze, Silver, or Gold




190 potential organ donors were referred to the team during 2018/19. There were 6 occasions where potential organ donors were not referred.

When compared with UK performance, the performance within the Trusts in the team was good (silver) for referral of potential organ donors to NHS Blood and Transplant.



Presence of Specialist Nurse for Organ Donation

Goal: A Specialist Nurse for Organ Donation (SNOD) should be present during every organ donation discussion with families



Aim: There should be no purple on the chart

Aim: The team (marked with a cross) should fall within Bronze, Silver, or Gold

A SNOD was present for 75 organ donation discussions with families during 2018/19. There were 7 occasions where a SNOD was not present.

When compared with UK performance, the performance within the Trusts in the team was average (bronze) for SNOD presence when approaching families to discuss organ donation.
