### Increasing the Number of Organs Available for Research – INOAR

INOAR 'go live' date October 23<sup>rd</sup>

Final go/no go meeting planned 3<sup>rd</sup> October with internal and external stakeholders to review the INOAR changes in practice across the entire donation, offering, allocation and retrieval pathway. The introduction of INOAR will result in changes for Organ Donation Services Teams, Hub Operations, the National Organ Retrieval Service, Information Services, and the Donor Records Department. Ian Bateman, Director of Quality will be present at the meeting as organs will be removed for research under the NHSBT research HTA licence (12608) in England, Wales and Northern Ireland and therefore requires assurance prior to 'go live'.

Retrieval Lead and RINTAG chair have written to NORS Centre Leads re INOAR with FAQs written specifically for NORS teams. Plans are also in place to communicate to retrieval practitioners and recipient co-ordinators via NHSBT leads Cecelia McIntyre and Katie Morley.

Phase 2 (removal of all organs) will require Business Case/Mandate/Budget/Resources and formal CPB approval

### Olf Bulb Retrieval

3 retrievals have taken place at ST Georges. RINTAG membership have agreed to allow 3 more retrievals to be facilitated, ST Georges Research Team are being more selective re cases as only 1/3 successful Olf Bulb retrievals have taken place.

### UTx

NHSBT continue to support the deceased donor uterine retrieval and transplantation trial, working with teams at Imperial College Healthcare NHS Trust (ICH) and Oxford University Hospitals NHS Foundation Trust (OUH).

Communications meeting 23<sup>rd</sup> August to agree communications plan in anticipation of significant interest in the trial from the media and elsewhere

Plan to train LODST September with 'go live' planned for November.

Innovation and Research CLOD to deliver Webinars to Donor Hospitals in preparation for 'go live' for medical and nursing staff to join. Attendance at Regional Collaborative Meeting November.

Coroners will be written to by Innovation and Research CLOD and RCLODs.

Communicating risk and consent in organ transplantation

Project request forms to be completed reviewed from the Business Transformation Team to review resource required to complete 2 elements of the project:

Patient Information

Transplant Risk and Consent Tools (TRCT)

We are aware that Transplant Risk and Consent Tools need to be considered alongside evolving guidance, Medical Device Directive is due to be replaced by the European Union Medical Device Regulation 2020.

Aide Memoir

Unable to progress due to internal resource constraints. External development costs ascertained from Sapient and potentially there will be the opportunity to re-explore if any underspend is identified at the end of the financial year. Internal NHSBT resource will still be required for initial design and testing.

European Day for Organ Donation and Transplantation (EODD)

UK hosting the 2019 European Donation Day (EODD), 12<sup>th</sup> October and European Committee (Partial Agreement) on Transplantation (CD- P- TO) meeting 10<sup>th</sup> and 11<sup>th</sup> October.

Peri-Mortem Interventions in Potential Organ Donors: The Development of a Statement from Professional Stakeholders

In Scotland, a slightly different approach is being taken with guidance on “pre-death procedure” as part of proposed deemed authorisation legislation.
