

# 1. EXECUTIVE SUMMARY FOR SEPTEMBER ODT SMT MEETING

- Sept 2019 3<sup>rd</sup> highest donor month ever (150 deceased donors)
  - o Donors per million population (pmp) increased throughout Q2, returning to March 2019 level (24.3 pmp)
  - o 8 more donors YTD, despite 58 fewer eligible donors (compared with same 6 months last year)
  - o 137 donors now needed per month to beat last year
    - But 161 donors needed per month to reach target
- Transplants pmp is still a major concern
  - o 40 fewer patients benefitted YTD, despite 8 more donors
  - o 347 transplants now needed per month to beat last year
    - 343 patients received a transplant in September
- ODR opt-in overrides are a real concern now
  - o 60 YTD (almost double the 31 YTD last year)

Objective 2 – Deceased organ donation – aim for 26 deceased donors per million population (pmp)#, equating to 1740 deceased donors in 2019/20.

Objective 3 – % of consented 'donors' with organ(s) accepted but no organ(s) transplanted\*.

Objective 4 – Patients transplanted – aim for a deceased donor transplant rate of 74 pmp#, equating to 4956 deceased donor transplants in 2019/20.

Objective 5 – Living Donation – aim for 26 living donors pmp#, equating to 1740 living donors in 2019/20.
