#### **Living Donation**

Thank you to colleagues in kidney transplant centres for submitting your individual plans for restoring living donor kidney transplantation and contingencies in the event of a future outbreak of COVID-19.

We have seen more centres restart living donation in the past week and the information that you have provided has already informed discussions within the kidney advisory group about how we progress with the kidney sharing scheme. We aim to confirm the timeframe for restarting this in the next week.

Advice to patients to note is:

- Follow comprehensive social-distancing and hand-hygiene measures for 14 days before admission (see government advice on social distancing)
- Have a test for SARS-CoV-2 from 3 days before admission, and ensure the results are available beforehand
- Self-isolate from the day of the test until admission

# **Transplant centres opening**

One unit remains closed to kidney transplantation. All other units are now open for deceased donor transplant. A full list of units now open can be found <u>here</u>. We are pleased to say that at the time of writing 16 units have opened to living kidney donation.

All other transplant centres liver, heart, lung, multi-visceral transplant centres are now open to transplantation. A few Islet and pancreas centres remain closed but are expected to re-open shortly.

### **Facilitating Organ Donation**

We continue to see a steady increase in donor and transplant activity. We have also removed any restrictions on donor criteria, for both DBD and DCD donors - we are back to pre-COVID-19 settings for all donor referrals.
