What happened to kidney transplantation during COVID-19?



Between 14th March and 10th April, 20 of the adult kidney transplant centres closed following the onset of the SARS-CoV-2 pandemic. Three centres remained open between 10th April and 14th April.


In response to the centre closures, the UK kidney offering scheme was amended from 30th March so that offers to Tier B patients would be centre choice. Named patient-based offering has remained in Tier A. All living donor transplants ceased from late March, and the April and July matching runs for the UKLKSS did not go ahead. NHSBT along with the Kidney Advisory Group has worked closely with centres to help facilitate the reopening of centres for both living and deceased donor transplantation.

All kidney transplant centres have now reopened and the offering scheme returned to patient-based offering in both Tier A and Tier B on 16th June. Deceased donor transplant activity has returned to the level in February. Living donor activity has started to increase from mid-May with the October UKLKSS planned to go ahead. However, living donor activity has not yet returned to previous levels.

What should I tell living donors about going into hospital?

There have been a number of queries related to guidance about living donors and social isolation before and after donation. Latest NHSBT/BTS guidance https://bts.org.uk/wp-content/uploads/2020/08/NHSBT-BTS-Consent-guidance-COVID-19-Version-4-updated-13th-August-FINAL.pdf and NICE guidance https://www.nice.org.uk/guidance/ng178/chapter/3-Transplant-donors#living-donors advocate individual discussion and risk assessment accompanied by close adherence to social distancing and hand hygiene.

The critical period is 14 days prior to donation and a similar period following discharge from hospital. Prior to donation, consideration needs to be given to the impact of late cancellation if a living donor is unable to proceed at a late stage. For example, if the donor is participating in a kidney sharing scheme exchange the implications of cancellation or postponement may be greater, simply because more people and centres are involved.

With an upturn in community prevalence, a return to more normal work and lifestyle activities and the advent of Autumn/Winter, the risk of infection is obviously increased. These factors, together with regional variation in COVID-19, will influence how individual transplant centres implement policies. This can cause confusion, so it is critical that local and regional policies are fully explained and that donors understand the need for tailored risk assessment and adherence to latest guidance.

DEcisions About Living Kidney Donation (DEAL KD) Research Project

Researchers at St James' University Hospital in Leeds and St Luke's Hospital in Bradford are conducting a study to ask services about the types of information they provide to their patients about living kidney donation. This work is conducted as part of the DEcisions About Living Kidney Donation (DEAL KD) research project funded by Kidney Research Yorkshire (ref 19-127). This project will develop a decision aid to help improve conversations around living kidney donation with a focus on BAME communities.
