#### **EU Withdrawal**

As of 31 December 2020 the UK is no longer part of the European Union.

Amendments have been made to the <u>Quality and Safety of Organs Intended for Transplantation Regulations (2019)</u> and the <u>Human Tissue (Quality and Safety for Human Application)</u> Regulations (2019).

Common Frameworks for organs, tissues and cells have been joint developed by officials in Scotland, Wales and Northern Ireland. They will formally establish ways of working to develop policy approaches for the area of organs, tissues and cells after the EU transition that ended in December 2020.

#### Legislation

Changes will be made to Wales's Excluded Relevant Material Regulations to bring them in line with other parts of the UK. #### **Communications and awareness**

The re-edited 'Don't Let Your Organ Donation be a Guessing Game' campaign is being relaunched on 25 January with broad coverage on TV, radio, social, digital, and Welsh language channels. This will be a highly visible 3 week campaign with an expected reach of 94% of all adults in Wales.

There is continued sharing of new case studies from a broad range of organ donation backgrounds, including a feature piece on ITV Wales news with cornea recipient and CBBC star, Angharad Rhodes.

Engagement levels across social media channels remain high, with new content weekly.

#### Wales Transplantation Advisory Group (WTAG)

The last meeting was held on 24 November 2020. An update was given on organ donation and transplantation performance which highlighted there was a light increase in DBD SNOD Presence rate from 90% to 93%. DBD referral rate is 98% and DBD Consent rate is 76%. The length of the donation process is still impacting on donor numbers.

There was an update on the draft Organ Donation and Transplantation Strategy and next steps, including discussion about the implementation process in Wales. A more detailed discussion on this aspect will take place at the next meeting.

The Group heard that the Organ Donation Communication Plan is currently focusing around the fifth anniversary of Deemed Consent in Wales; the Minister has recorded a message for social media.

The Group was advised that the appointment of the Welsh Member to the Human Tissue Authority had been re-advertised after the exercise carried out before Christmas did not appoint. The closing date is 1 February.

Next WTAG meeting to take place is 2 February 2021.

## Update from Welsh Blood Service (WBS)

As of 14 December, all 4 UK Health Ministers agreed to lift the ban on deferral of MSM donating blood, subject to a revised risk assessment. The outcome of the RECOVERY trial was announced on 15 January. Unfortunately it was found to not be efficacious in the ITU population. WBS has been collecting Convalescent Plasma as part of the trial and WG are now in discussions with them regarding the next steps. It is understood that NHSBT are putting forward a further trial for the use of CP and WG will await the outcome of this before taking work forward.
