## Categorisation of Donation Activity by Level

### Levels – based on number of proceeding donors

Acknowledging the impact of the pandemic, two calculations were made for each Board/Trust, and the most favourable (highest level) was allocated.

- Average number of proceeding donors over three years (2019/20, 2020/21, 2021/22)
- Average number of proceeding donors over two years, excluding the COVID year (2019/20, 2021/22)

1	12 or more ( $\geq 12$ )	36
2	6 or more but less than 12 ( $\geq 6$ to $<12$ )	51

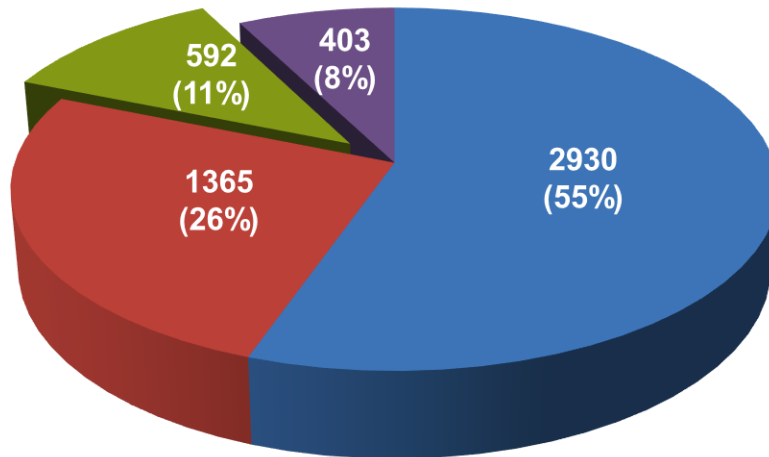

### Potential DBD/Eligible DCD donors

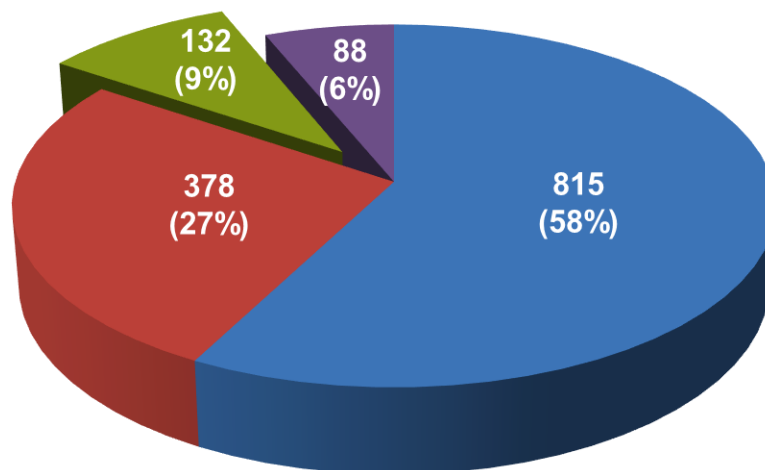

**Potential donors after brainstem death (DBD)** are defined as patients who have neurological death suspected by meeting all of the following criteria: apnoea, coma from known aetiology and unresponsive, ventilated, fixed pupils, no cough or gag reflex. Excluding those for whom cardiac arrest occurred despite resuscitation, brain stem reflexes returned.

**Eligible donors after circulatory death (DCD)** are defined as patients who had treatment withdrawn and death was anticipated within four hours, with no absolute medical contraindications to solid organ donation.

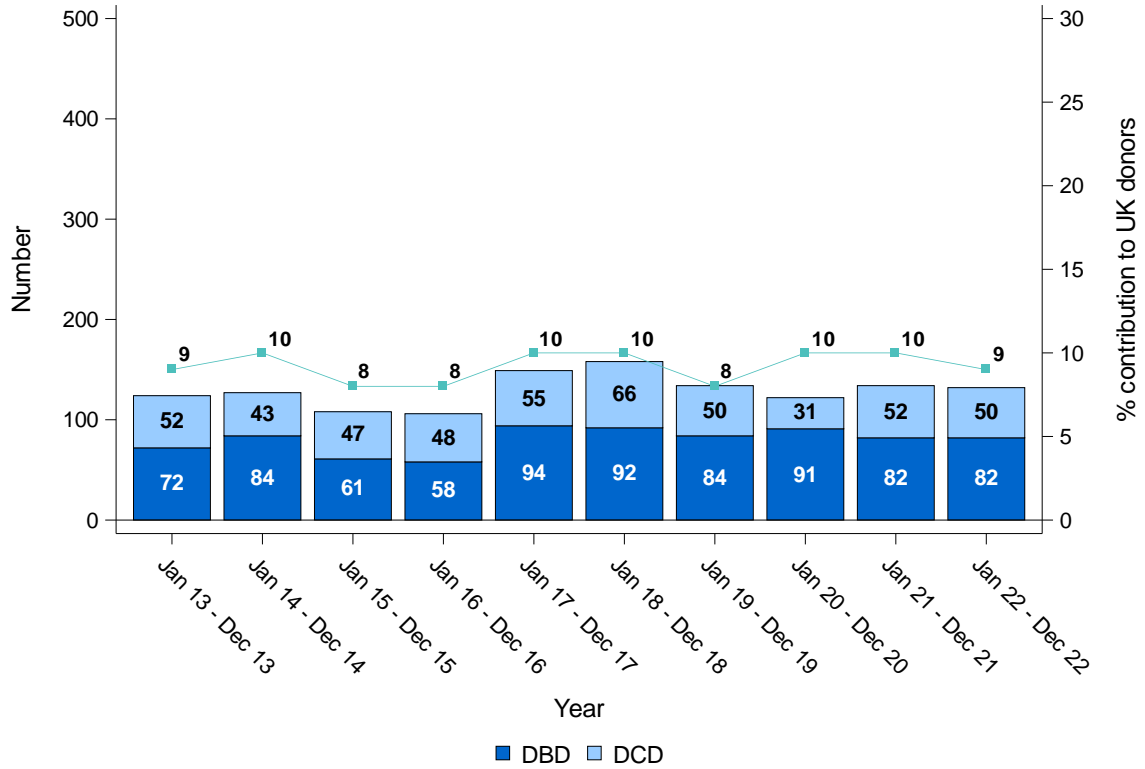

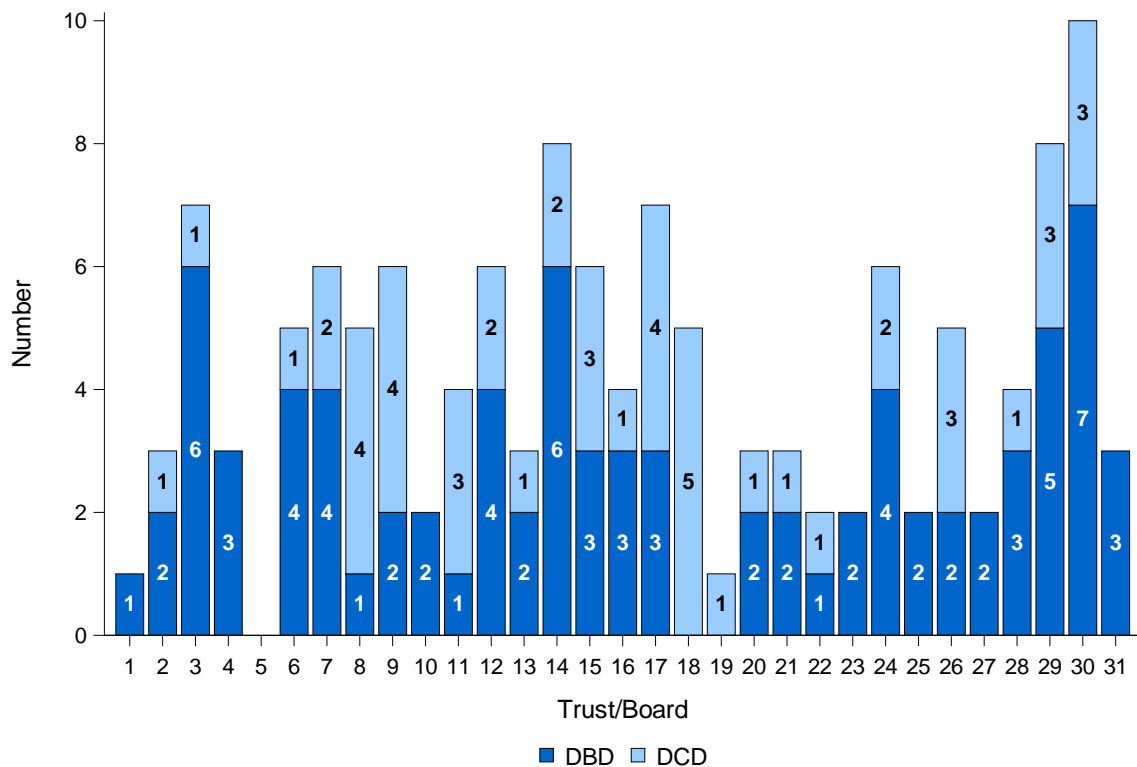
## Level 3 Group actual deceased donors

1 January 2013 - 31 December 2022



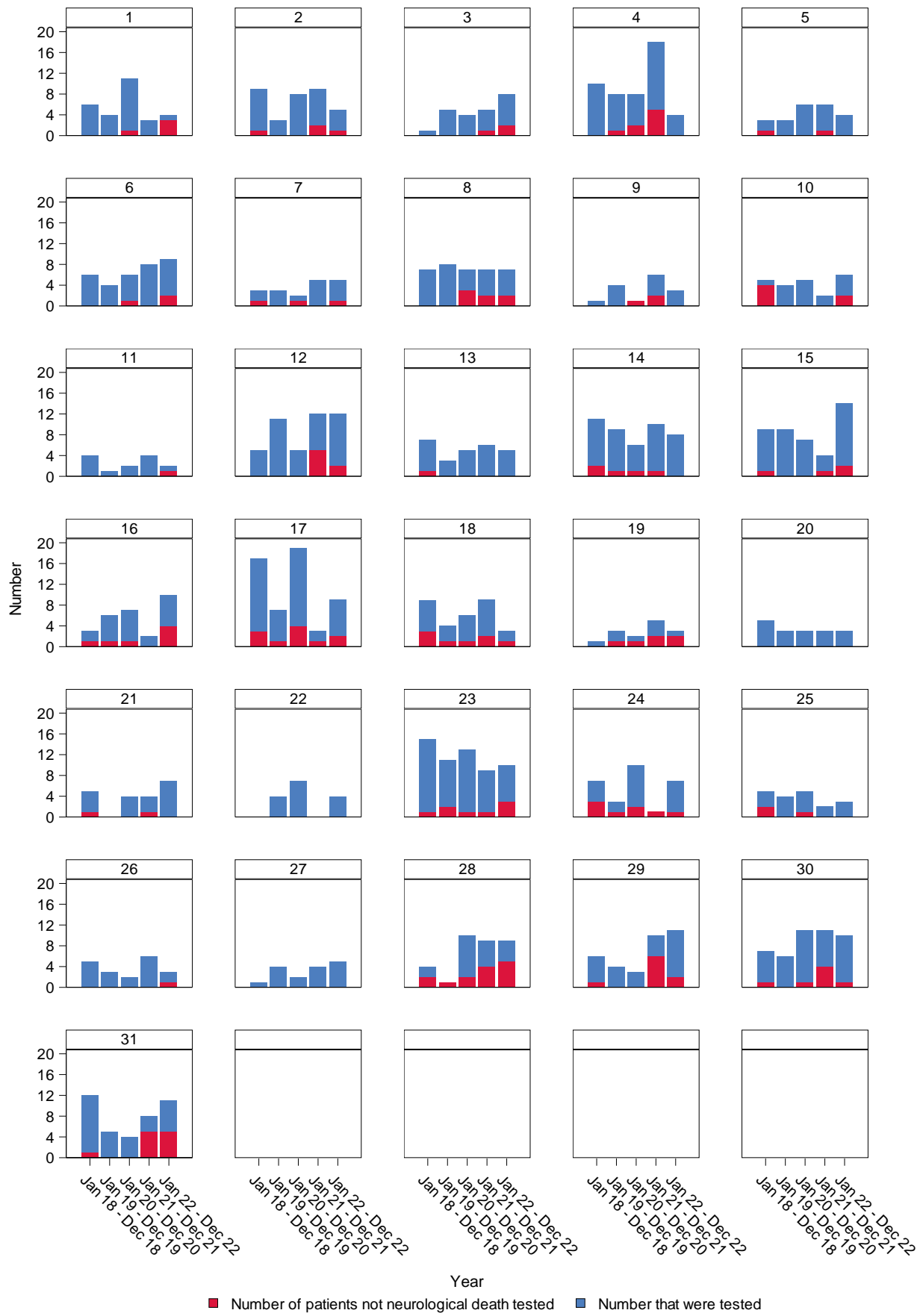
## Level 3 Group actual deceased donors by trust/board

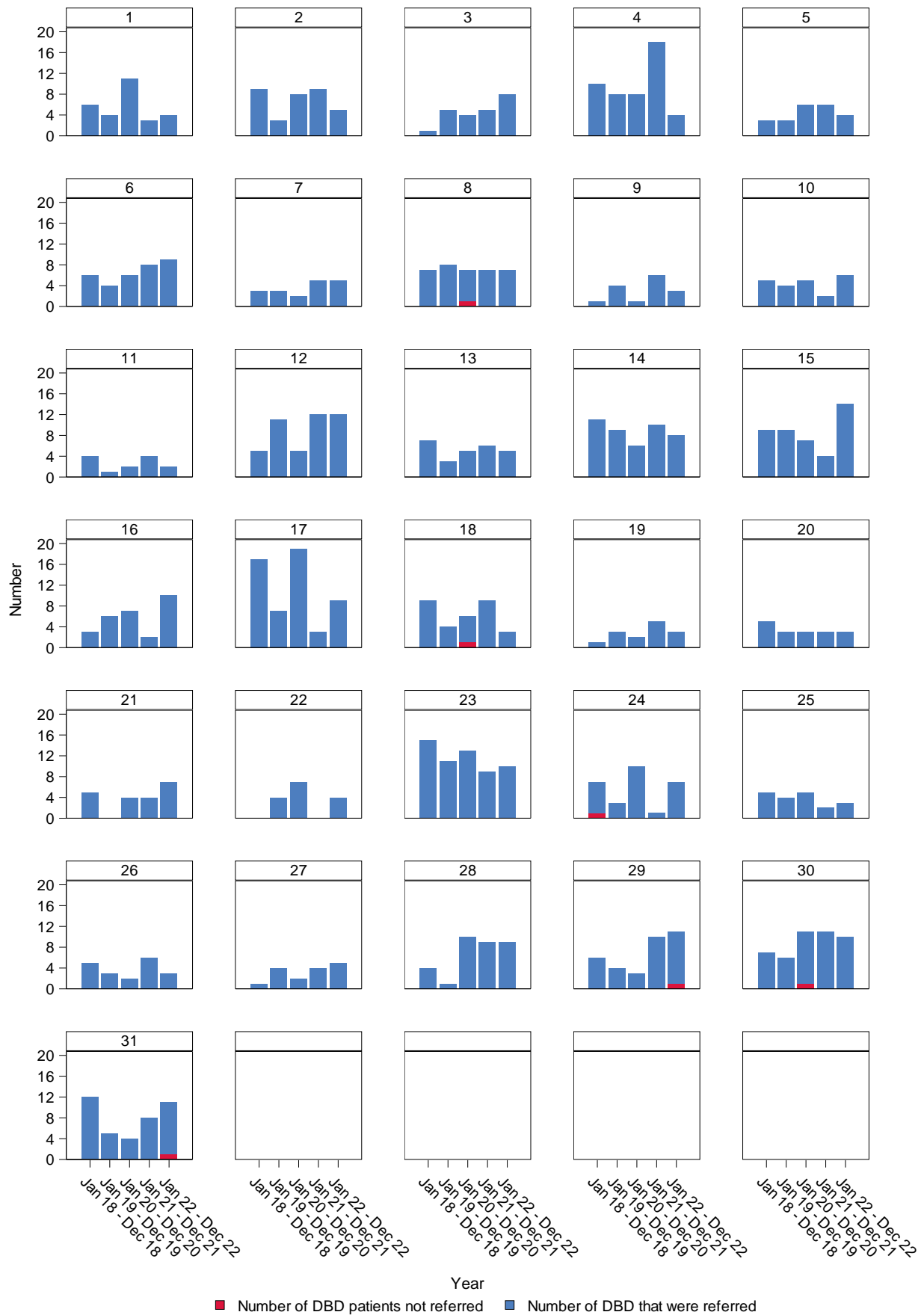
# Level 3s neurological death testing

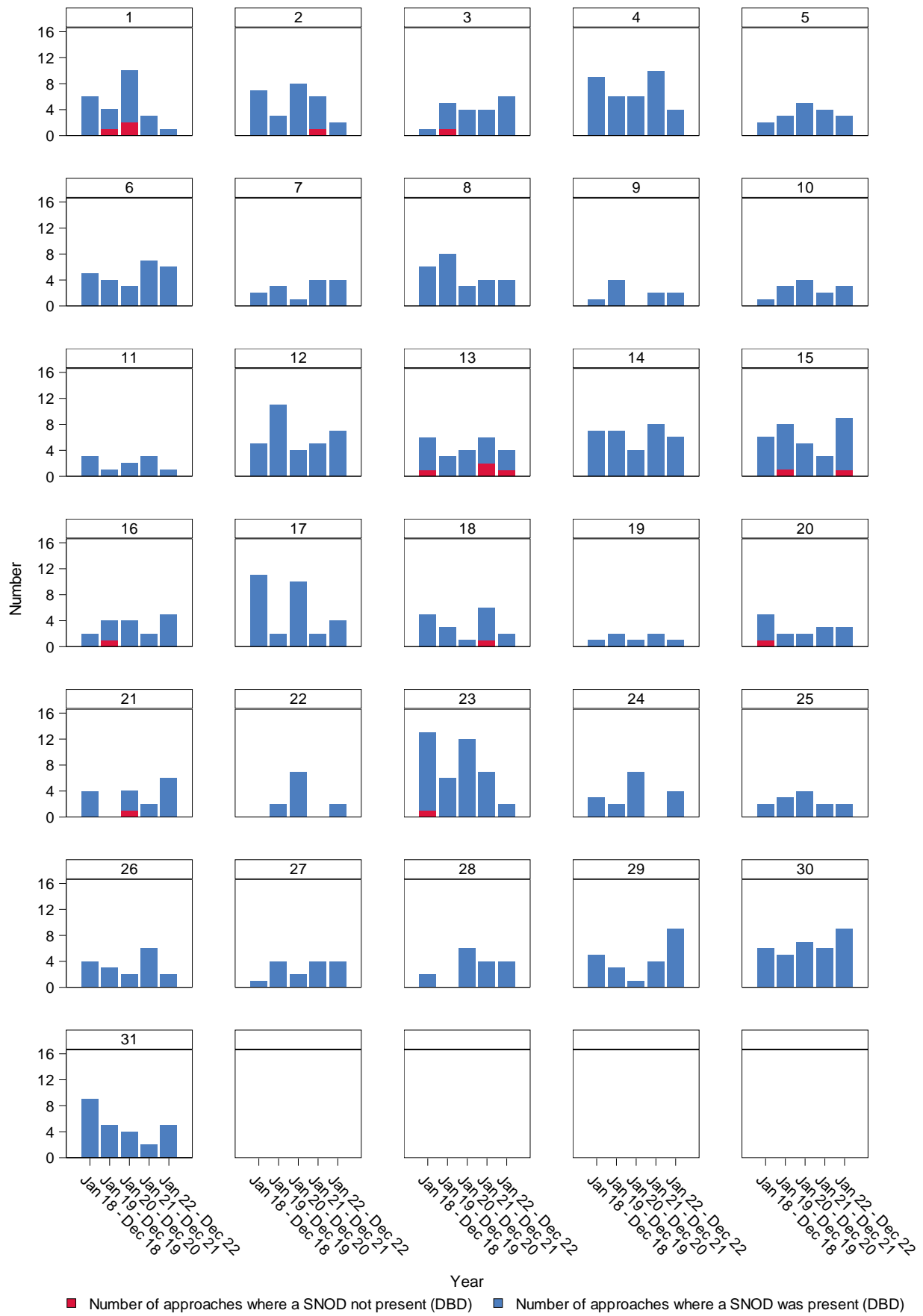
# Level 3s DBD referral

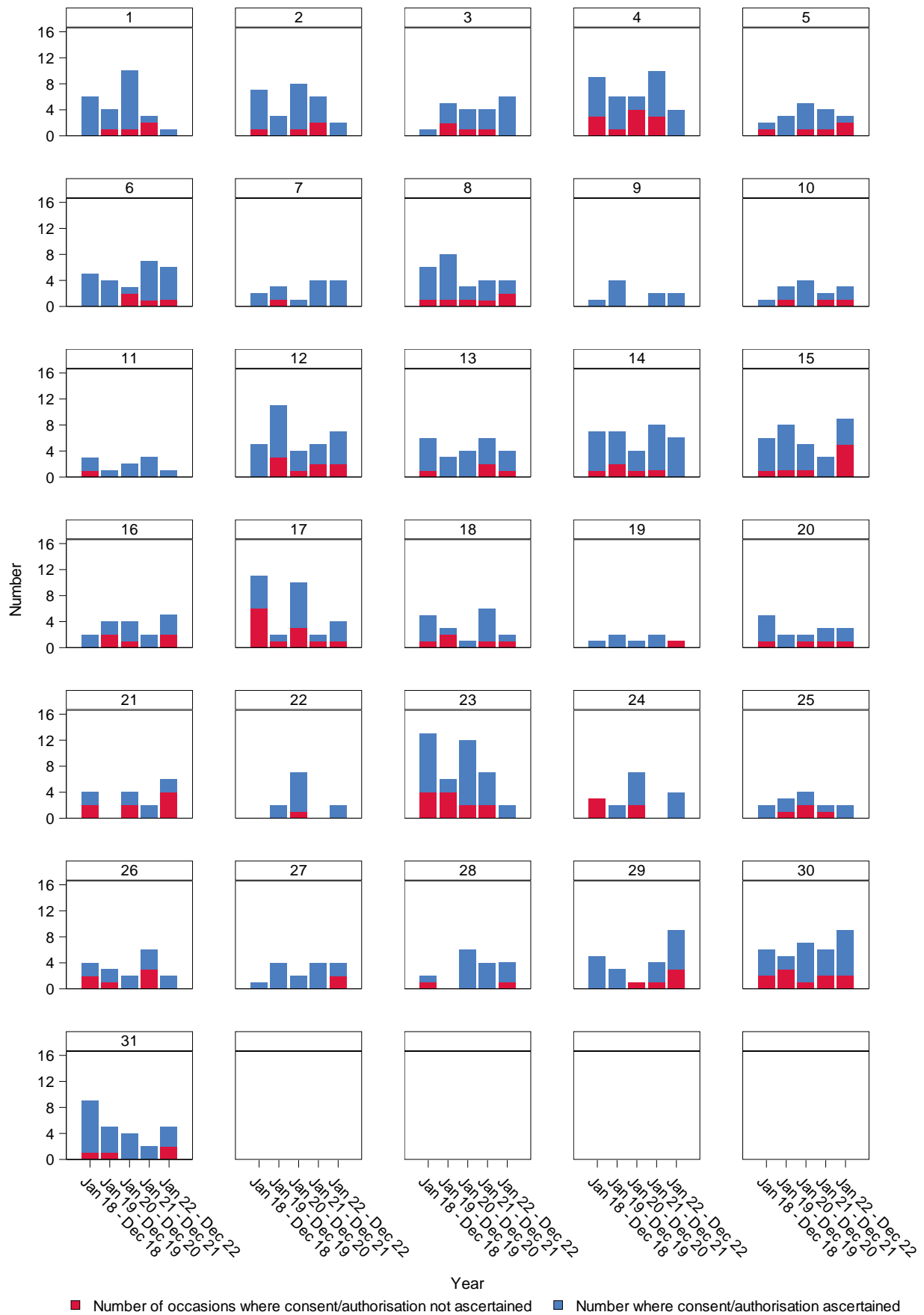
# Level 3s DBD SNOD presence

# Level 3s DBD consent/authorisation

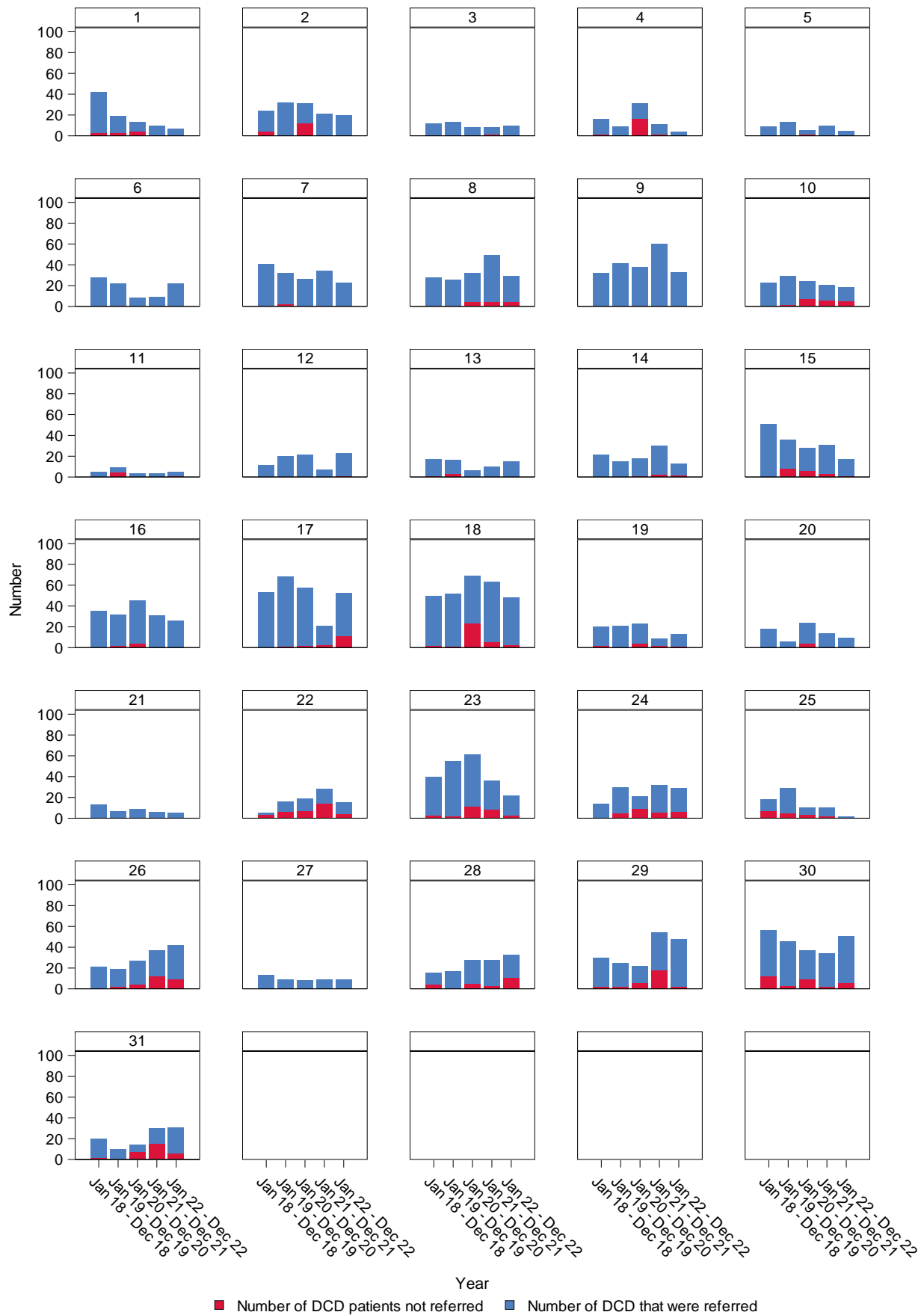

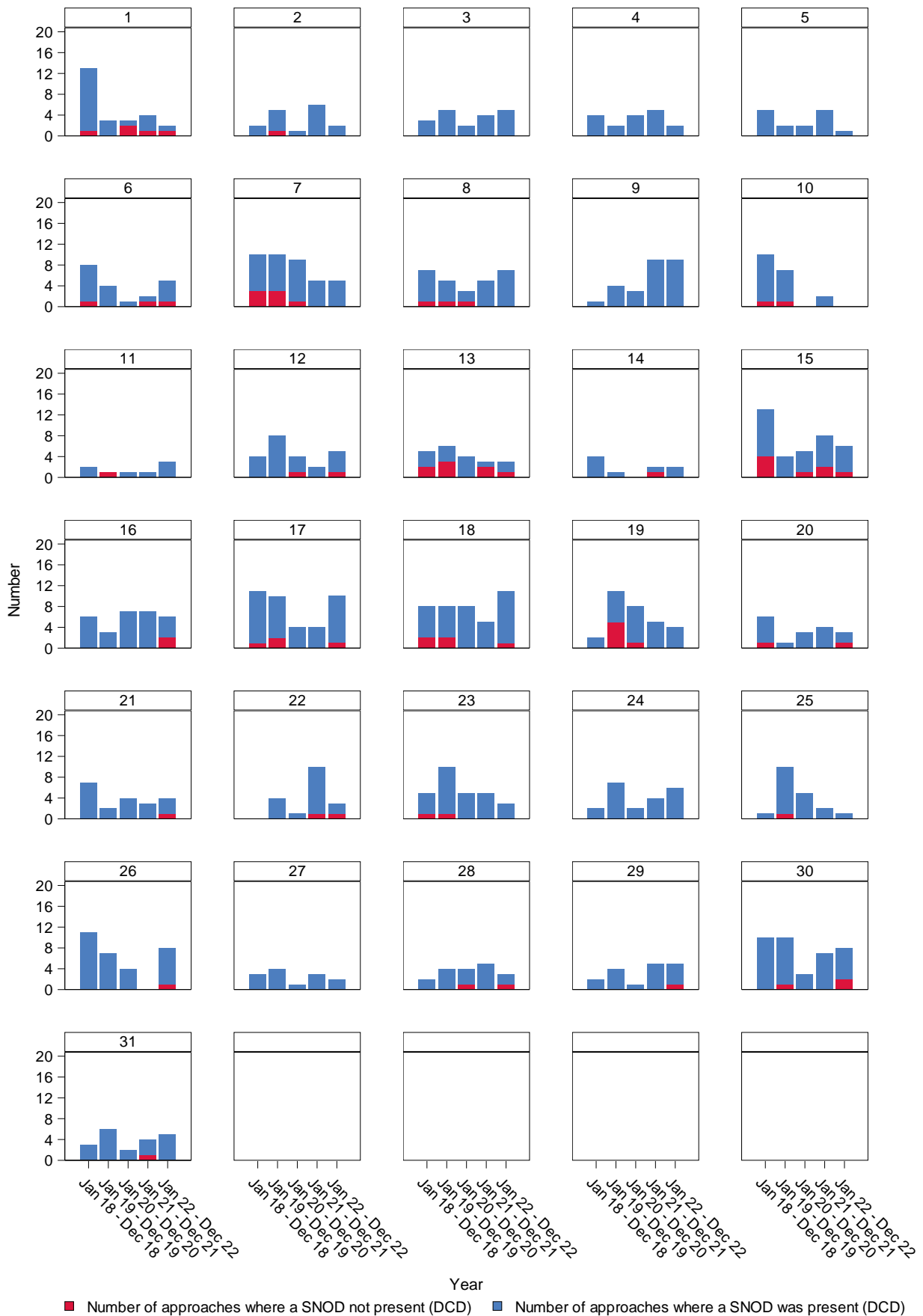
# Level 3s DCD referral

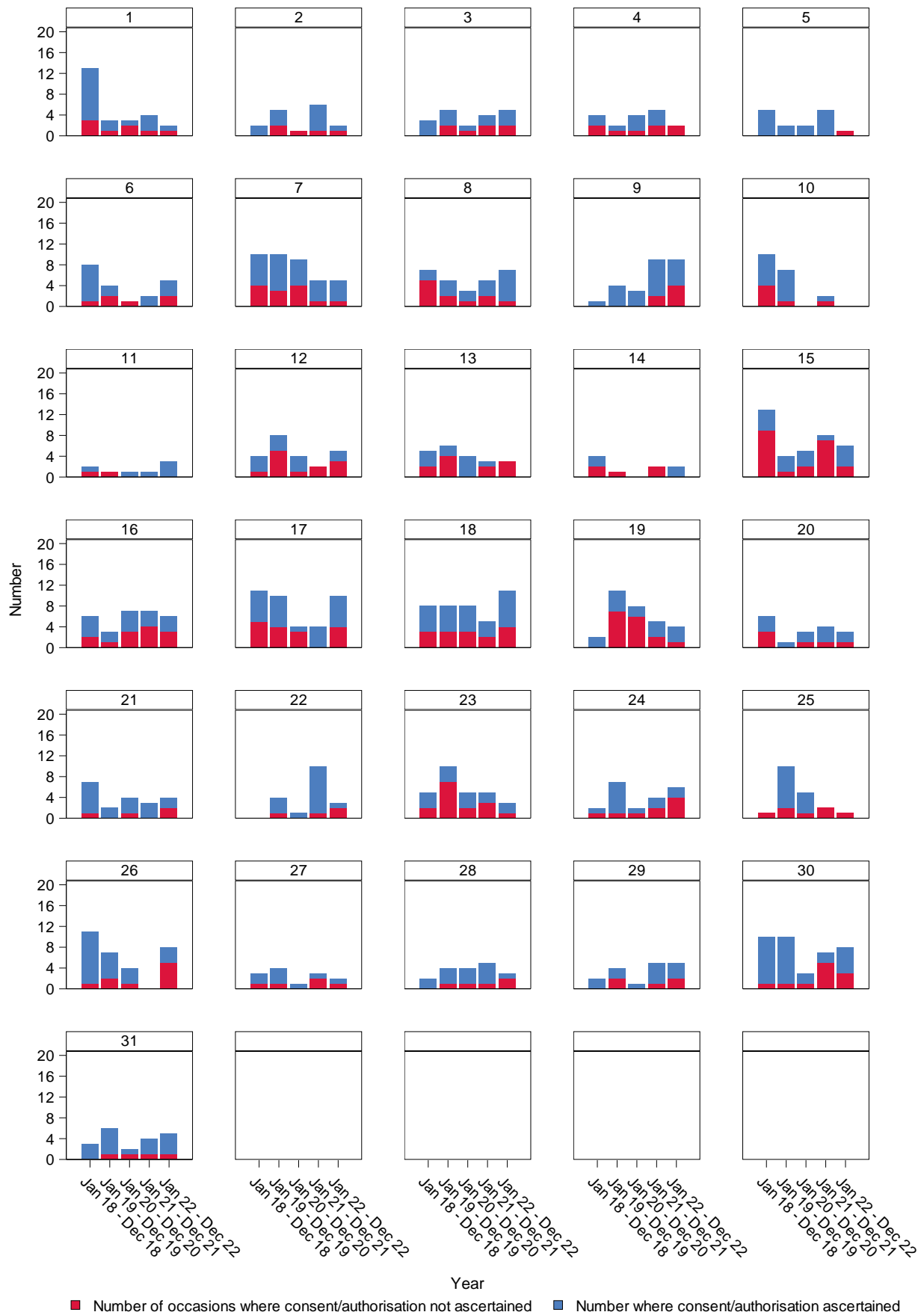
# Level 3s DCD SNOD presence

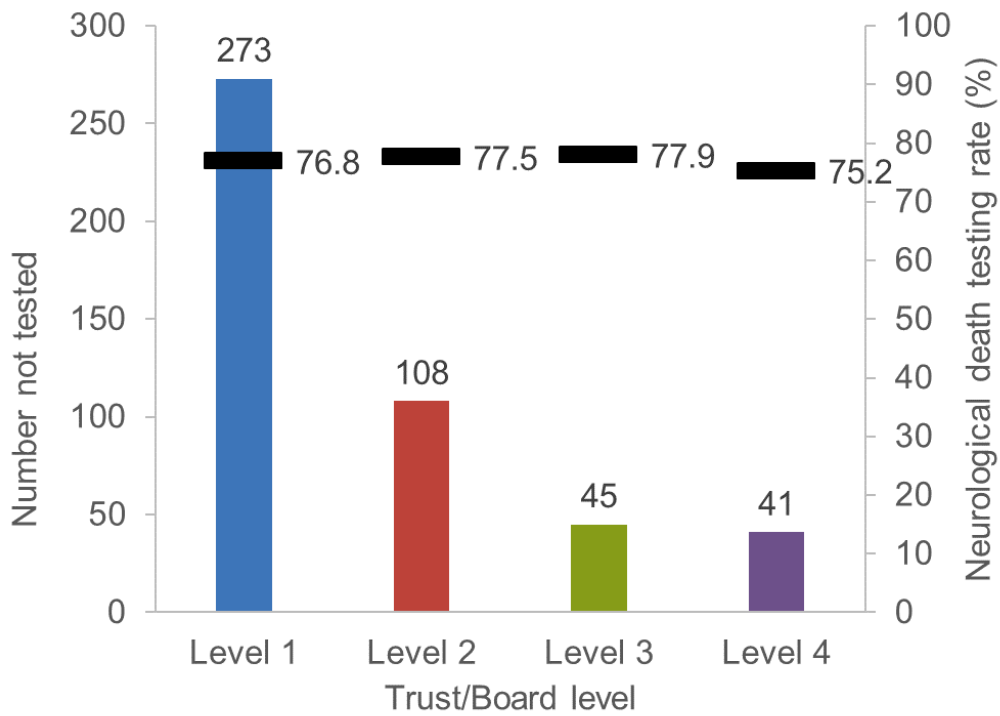

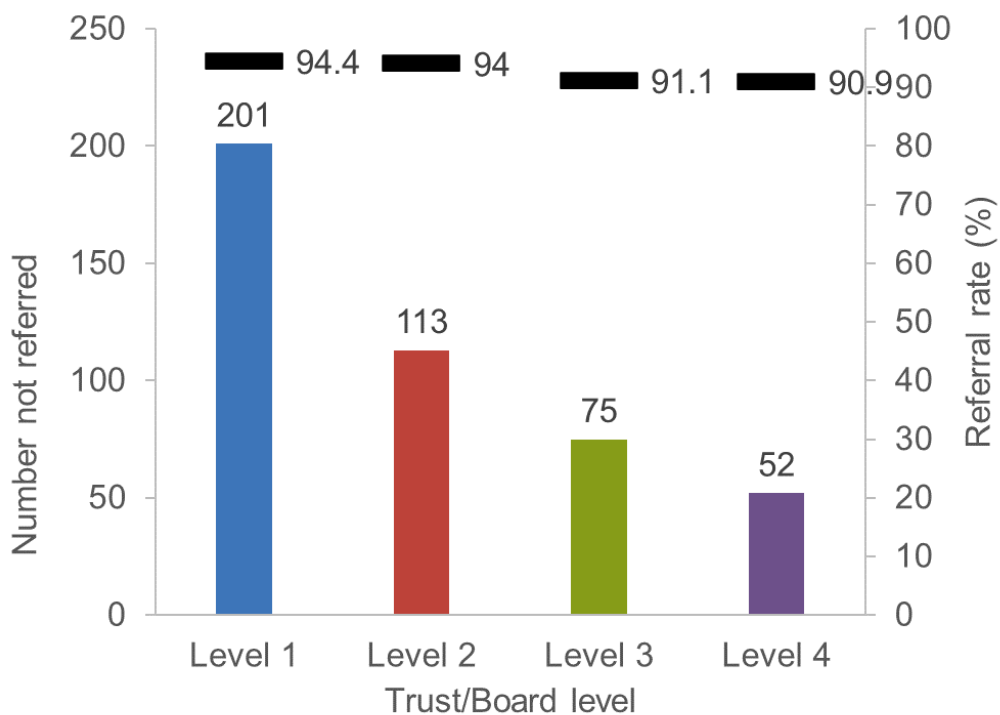
## Comparison of neurological death testing by level

1 January 2022 - 31 December 2022



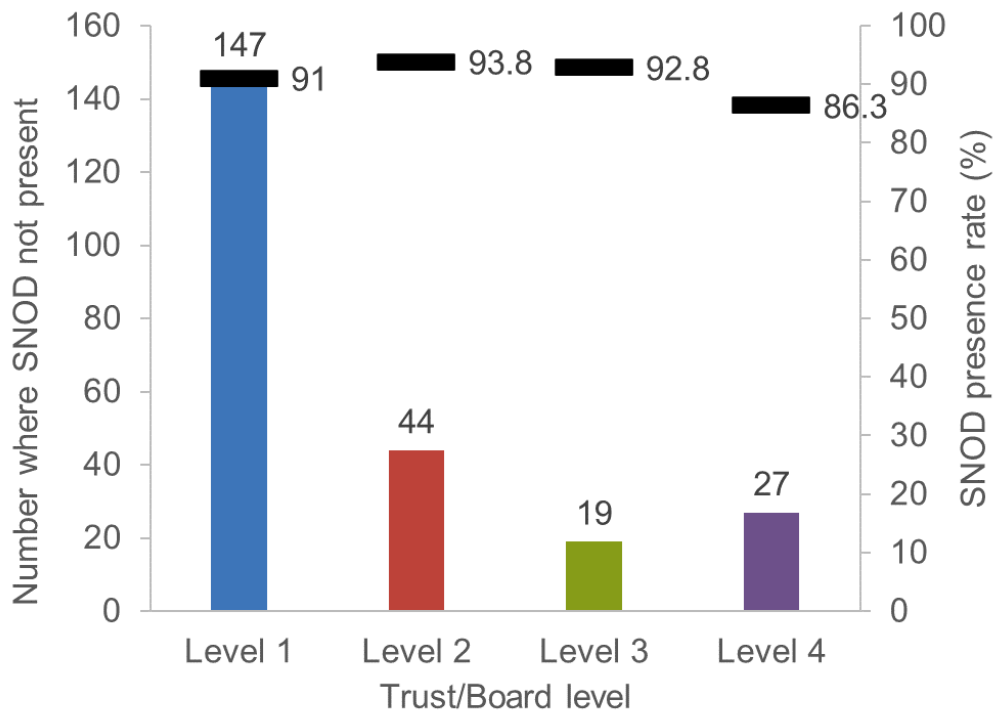
## Comparison of combined DBD and DCD referral by level

1 January 2022 - 31 December 2022



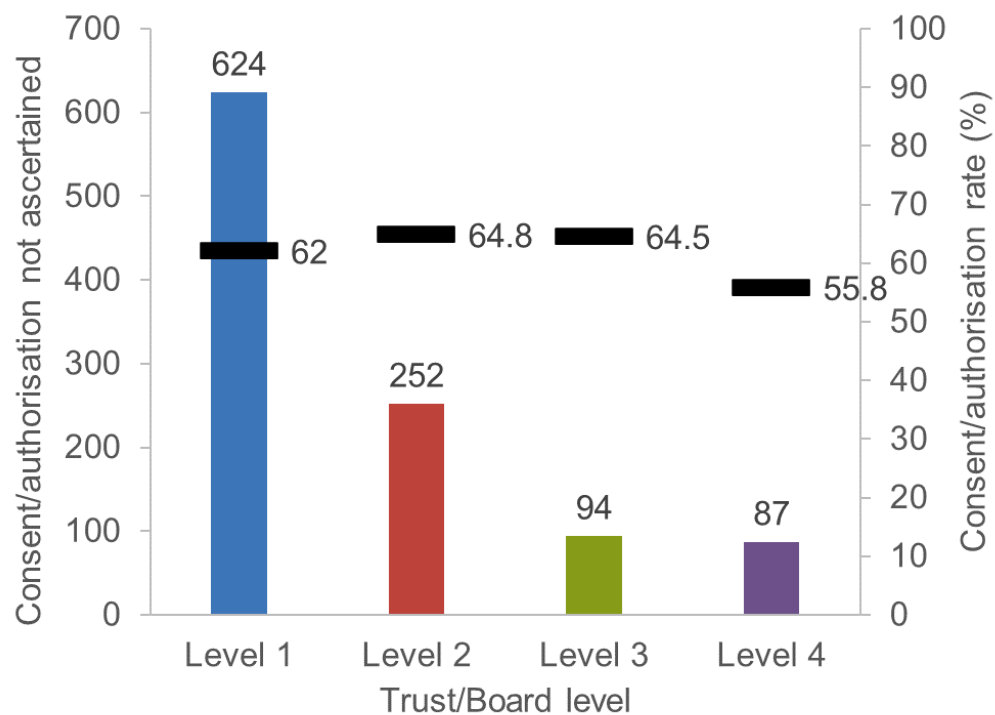
## Comparison of combined DBD and DCD SNOD presence by level
