#### Taking Organ Transplantation to 2020

In 2020/21, from 4 consented donors the Trust facilitated 3 actual solid organ donors resulting in 7 patients receiving a life-saving or life-changing transplant. Data obtained from the UK Transplant Registry.

In addition to the 3 proceeding donors there was one consented donor that did not proceed.


### Best quality of care in organ donation

## Referral of potential deceased organ donors

Goal: Every patient who meets the referral criteria should be identified and referred to NHS Blood and Transplant's Organ Donation Service

Patients not referred Patients referred


The Trust referred 23 potential organ donors during 2020/21. There were 9 occasions where potential organ donors were not referred.



## Presence of Specialist Nurse for Organ Donation

# Goal: A Specialist Nurse for Organ Donation (SNOD) should be present during every organ donation discussion with families

#### Aim: There should be no purple on the chart



A SNOD was present for 4 organ donation discussions with families during 2020/21. There were no occasions where a SNOD was not present.

## Why it matters

• If suitable patients are not referred, the patient's decision to be an organ donor is not honoured or the family does not get the chance to support organ donation.

• The consent rate in the UK is much higher when a SNOD is present.

• The number of patients receiving a life-saving or life-changing solid organ transplant in the UK is increasing but patients are still dying while waiting.
