There were no proceeding donors however there was one consented donor that did not proceed.


### Best quality of care in organ donation

Patients not referred


The Trust referred 4 potential organ donors during 2020/21. There were no occasions where potential organ donors were not referred.



# Presence of Specialist Nurse for Organ Donation

# Goal: A Specialist Nurse for Organ Donation (SNOD) should be present during every organ donation discussion with families

### Aim: There should be no purple on the chart



A SNOD was present for 3 organ donation discussions with families during 2020/21. There were no occasions where a SNOD was not present.

# Why it matters

• If suitable patients are not referred, the patient's decision to be an organ donor is not honoured or the family does not get the chance to support organ donation.

• The consent rate in the UK is much higher when a SNOD is present.

• The number of patients receiving a life-saving or life-changing solid organ transplant in the UK is increasing but patients are still dying while waiting.
