Stock Update and Bank Holiday Service Provision

Dear Colleague

Since declaring an Amber alert for group O red cells on 25 July, our stock has continued to improve. However, group O remains vulnerable to changes in donation and hospital demand. We need to be confident that we can transition out of Amber and maintain support for hospitals seamlessly; at this time we do not have that confidence.

We remain at Amber level for group O red cells and ask that you maintain your Emergency Blood Management Arrangements. We expect the Amber alert to continue until at least early September, however we will keep this position under close review. We remain at pre-Amber level for group A positive and group B negative red cells, and group A negative platelets.

We would like to thank all hospitals that have supported us and ask that you continue to review stock holding and maintain best inventory practice and Patient Blood Management initiatives.

We are continuing to take action to improve staff capacity at donor sessions and encouraging as many donors as possible to donate. We have seen a great reaction from donors. Our message to people wanting to donate that can't find an immediate appointment is to please book ahead as we need donations in coming months as well as right now. We apologise for the extra work and inconvenience these restrictions will cause.

A limited supply of granulocytes will be available as shown on the table below. We cannot guarantee supply, as granulocytes are a limited stock item. Delivery times may be longer dependent on location of the component at the point of issue.
