#### Summary of Significant Changes

Step 2- Addition of Neonatal Donor Assessment and Organ screening Form FRM 5510 and clarification of Designated Screening Centres for neonates and children <5kg +/- <2 months of age.

### **Purpose**

The purpose of this document is to guide the SNOD through the formal screening process when the SNOD needs clinical advice for a DCD kidney donor suitability decision.

#### Responsibilities

The SNOD must carry out the assessment as per usual either by phone or at the donor hospital, which will inform if:

- A) The SNOD can proceed with consent/authorisation
- B) The SNOD requires clinical guidance to make that decision

If the SNOD requires clinical guidance they will ring:

1<sup>st</sup> – Local Designated Screening Centre

2<sup>nd</sup> - Designated Screening Centre within the region or Leeds if neonate or child <5kg +/- <2 months of age.

The SNOD will document the reasons for unsuitability as a kidney donor from the Screening Centres for audit purposes

### **Important**

The screening process should take no longer than 30 minutes to complete.

If the centres are difficult to contact or the screening decision may take some time, contact an alternative screening centre.

If the Designated Screening Centre is Leeds, also call a second Designated Screening Centre. Two centres must be contracted prior to decline of organs on screening.
